The following is the detailed report of the responses. I: Students Feedback The students stated that the college is motivational and inspiring, the course objectives and outcomes of the course are clearly communicated to them by the teachers. They rated the teachers as outstanding in terms of subject knowledge and awareness of the new trends and they are easily approachable and assisted them in identifying their strengths. The teachers are sincere, regular and committed and completed the syllabus on stipulated time. They rated facilities like availability of books and journals from library, cleanliness, sanitization as outstanding. They were motivated and encouraged to participate in all activities. Very good Health care facilities are provided. They felt easy accessibility of information. Overall, they rated outstanding impression on the college. Further they suggested that advanced equipment in laboratories be provided and should be updated every year. Can provide better placement options, little more interactive facilities to be needed. Proper drinking water facilities and hygiene washrooms to be provided. As it is a women's college, it is better to appoint only women employees at all levels, then real women empowerment is enhanced. The Identity cards to be made mandatory for entering the college as many outsiders who don't have any connection with the college and hostel are entering which make them feel insecure. II: Teachers Feedback Teachers have strongly agreed that the Curriculum includes Contemporary courses/topics relevant to industry/Economy needs, the course objectives and outcomes are clear to the students the syllabus taught focused on the employability/ Entrepreneurship skills, the syllabus of each course meets the respective course and program outcomes and has good balance between theory and application. The syllabus is also relevant to succeed in competitive exams. The teachers felt freedom to propose revision/ incorporate new topics due to the autonomy of the college and a good library where sufficient books and E-sources available to students to utilize. The

Teachers suggested that there should be a separate library at each department and ICT facility may be used effectively and make easy accessibility to all students for online classes. III: Parents Feedback The overall impression of the parents on the college is outstanding. Majority of the parents felt that women's college -Koti is the best girls' educational institute in the state with good academic discipline. The teachers are very supportive, encouraging and experts in subject domain. The college also imparts skills with multi-Disciplinary courses. The college had good infrastructure facilities. The college provided good placement and career guidance to students. They opined that the students are also encouraged with extracurricular activities like Sports/ NSS/NCC.
